



TRAMPOLINE CENTER LIABILITY WAIVER

Please carefully read the Trampoline Center Liability Waiver and the accompanying annexes ("Waiver") before signing.

The meaning of terms and definitions referred to below in the Waiver:

A. "Company" – refers to Skakaonica Ltd. Company Beograd – Savski Venac, based in Karađorđeva 49/3/17, Belgrade – Savski Venac, Company Number 21497193, Tax ID Number 111530893..

B. "Trampoline Center" – fun and recreational space, including equipment and facilities designed for recreational and sporting activities of the Participant (as defined hereinafter), representing the property of or in the possession of the Company.

C. "Services" – recreational, sporting and other related services provided by the Trampoline Center, with the service type, scope and duration to use the Services of the Trampoline Center in a manner and in accordance with the terms of the Safety Protocol ("Protocol"), which is annexed hereto as Annex 1, representing an integral part of this Waiver.

E. "Safety Requirements" – a set of rules and required conduct of the Participants during the visit to the Trampoline Center regarding the manner and terms of Services provided by the Company within the Trampoline Center as defined by the Protocol.

F. "Personal Data" – refers to user data, including:

- (I) full name of the Participant, full name of a parent or legal guardian of the Participant;
- (II) residence address of the Participant, and
- (III) phone number and email address of the Participant.

If the Participant is a minor, personal data are provided by a parent or a legal guardian of the Participant when signing the Waiver.

Phone number and e-mail address are optional personal data, in accordance with the **Law on Protection of Personal Data (the "Law")** and **Personal User Data Collection Notice ("Notice")**, annexed hereto as Annex 2, representing an integral part of this Waiver.

- I agree that the Trampoline Center Services can only be used after reading the content of the said Waiver, the accompanying annexes and by providing signature;

- I understand that using the Services of the Trampoline Center constitutes an inherently risky recreational activity with regards to potential undesirable consequences to life and health. In this respect, I further certify and acknowledge the possible increased risk of injury, including but not limited to sprains, breaks, bruises and, exceptionally, the possibility of serious injury, disability or death in the most extreme cases;

- I agree to be personally and solely responsible for my own health, including the health of the Participant of whom I am parent or legal guardian, both in terms of taking all precautions aimed at preventing adverse effects of the activities to health while using the Services, as well as related to providing all the relevant information about the current health conditions that may be of influence or importance for using the Services;

- I agree to use the Trampoline Center and Services in a safe and responsible way, with respect for other Participants and visitors of the Trampoline Center, and that I will not attempt any Trampoline Center activities beyond my age or skills. I further certify that I will not undertake any of the activities as part of the Trampoline Center Services unless I am sure I can safely and securely perform the activity, considering my health condition, knowledge, experience and physical abilities;

- I hereby agree to indemnify and hold harmless the Company for any damages caused by (i) worsened and/or impacted health during or after the use of Services (ii) injuries caused by or resulted from the activities or the Trampoline Center Services;

- I agree that during my visit to the Trampoline Center, I am obliged to take care of my possessions in an appropriate manner and that the Company is under no obligation to keep my possessions safe, and in this regard, the Company does not bear any responsibility in case of loss or damage of my possessions during my visit to the Trampoline Center;

- I acknowledge that I am familiar with all the safety requirements in accordance with the Protocol and that I will carefully follow all the guidelines, including the instructions by the Trampoline Center or Company staff;

- I agree the concerned Waiver is in effect for 1 (one) year after the date of signing and valid for subsequent visits to the Trampoline Center.
